Who owns the shares?

There are 2,406,416 ordinary shares held by our 1000+ members and 1,559,862 redeemable preference shares held by 3 directors, primarily the chairman, Bay de Lautour who holds 1,305,979 shares.

These preference shares hold no voting rights and do not qualify for dividends or rebates. They were invested during tough times, to ensure the Co-op remained in operation for the benefit of its members. These shares are now being redeemed as funds permit.

If Bay de Lautour owns the majority of the shares, doesn't he have control?

It's true that Bay is the majority shareholder. However to ensure this stays in balance, the Constitution specifically states that every shareholder has one vote per share but the maximum number of votes is limited to 20,000 per shareholder.

Why supply wool with Elders Primary Wool in addition to shareholding?

Your co-op owns 50% of Elders Primary Wool. Supplying wool to Elders Primary Wool increases their profit and in turn the 50% share of their profit that comes back to your co-op. Members supplying wool to Elders Primary Wool also receive rebates and qualify for discounted woolpacks.
