As the seasonal peak volume of wool eases, we are at last seeing strengthening prices again and even the poorer coloured wools are starting to move up in price. A slight easing in the dollar has also been a help. The wool that is being purchased is leaving the wool stores very quickly which indicates it is going directly into manufacturers orders rather than being bought to hold for later delivery.

As many of you may be aware, the Boards of Wool Equities Ltd and Primary Wool Co-operative Ltd met to discuss the uniting the entities for the benefit of shareholders and the wider New Zealand wool industry.

The Primary Wool Co-operative board have consulted legal, financial and industry advisers and visited Wool Equities Ltd manufacturing subsidiary and associate. However, we reluctantly concluded that the investment required and the level of security available meant the Board was unable to recommend an investment in Wool Equities Ltd to its 1100 member shareholders at this time.

Know that we consider uniting the wool industry an important task and we are disappointed that we are unable to work together.
